The Walk of Life is a pathway which meanders its way beneath the trees in the St Christopher's Bromley garden at Caritas House.

Bricks are placed on the path when families and friends have raised £1,000 or more in their Tribute Fund in memory of someone that has died. Donations do not need to be from just one person and can come from money raised in different ways, such as taking part in an existing or your own fundraising event or from funeral donations. Alternatively you can make a regular donation of at least £10 per month to St Christopher's by setting up a Direct Debit.
